Pennsylvania's General Assembly created the Independent Regulatory Review Commission to provide independent oversight of the rulemaking process in Pennsylvania and to establish an ongoing and effective review of agency regulations. The Commission's mission is to review agency regulations in order to determine whether they are in the public interest. By evaluating the conformity of rulemakings with law, and their impact on the public and regulated community, we assist the General Assembly and the Governor in achieving a favorable regulatory balance and ensure the integrity of the regulatory process. This annual report details the Commission's activities in 2021.

In 2021, the Commission reviewed a total of 89 regulations, including 45 proposed and 44 final regulations. Almost 24,000 public comments were submitted on pending regulations in 2021. Seven comments were submitted by legislative standing committees and 439 legislative comments were submitted by individual House and Senate members.

Notable regulations reviewed by the Commission in 2021 include: CO₂ Budget Trading (Environmental Quality Board #3274); Medical Marijuana (Department of Health #3290); Standards for Drug and Alcohol Recovery House Licensure (Department of Drug and Alcohol Programs #3294); and Long-Term Care Nursing Facilities (Department of Health #3312).

Looking ahead, the Commission will continue its role as an independent oversight body reviewing agency regulations and determining whether the criteria set forth in Pennsylvania's Regulatory Review Act have been satisfied.

Proposed Regulations

The following is an explanation of the action codes for Proposed Regulations:

- NONE** Commission did not submit comments.
- OPEN** Regulation was received in 2021 with Commission action due in 2022.
- WDN** **Withdrawn** – A regulation submitted as proposed that was withdrawn by the Agency after IRRC issued comments.
- W2Y** **Withdrawn Under Section 5.1(a)** – A regulation submitted as proposed, but not delivered in final-form within two years of the close of the public comment period, and consequently, deemed to be withdrawn.
- *** Final-form regulation delivered in 2021.

Final Regulations

The following is an explanation of the action codes for Final Regulations:

- ABL** **Approved by Law** – The final regulation was deemed to be approved because the Commission did not submit any comments on the proposed regulation, the regulation was not modified from its proposed form and the designated standing committees did not disapprove the final regulation.
- APP** **Approved** – The final regulation was approved.
- DIS** **Disapproved** – The final regulation was disapproved by the Commission at its public meeting.
- LAC** **Later Approved with Changes** – After an initial disapproval, the regulation was approved with changes at the Commission's second public meeting.
- N/A** Indicates this was a final-omitted regulation and was, therefore, not published in the *Pennsylvania Bulletin* for public comment.
- OPEN** Regulation was received in 2021 with Commission action due in 2022.
- WDN** A final regulation submitted but withdrawn prior to Commission action. A withdrawn final regulation may be resubmitted within two years after the close of the public comment period. A withdrawn final-omitted regulation may be resubmitted as a new final-omitted regulation at any time.
