State Board of Vehicle Manufacturers,
Dealers and Salespersons
Vehicle Auction License

On October 17, 2002, the Independent Regulatory Review Commission (Commission) received this proposed regulation from the State Board of Vehicle Manufacturers, Dealers and Salespersons (Board). This rulemaking adds 49 Pa. Code §§ 19.19 and 19.20. The proposed regulation was published in the November 2, 2002 *Pennsylvania Bulletin* with a 30-day public comment period. The Board resubmitted the proposed regulation on February 4, 2003, pursuant to Section 5(e) of the Regulatory Review Act, which was in effect at the time the regulation was proposed. The final-form regulation was submitted to the Commission on June 8, 2004.

The Board is establishing requirements for retail or public vehicle auctions and wholesale vehicle auctions. The regulation prescribes minimum vehicle display standards and mandates compliance with land-use ordinances and fire codes.

We have determined this regulation is consistent with the statutory authority of the Board (63 P.S. § 818.4(a)(9)) and the intention of the General Assembly. Having considered all of the other criteria of the Regulatory Review Act, we find promulgation of this regulation is in the public interest.
