Dear Re: Water Quality Standards; Class A Stream Redesignations,

I submit these comments in support of the Environmental Quality Board's proposal to amend the Pennsylvania Code to provide an extra layer of protection to approximately 207 miles of Pennsylvania's streams. 46 Pa. Bull. 1205 (March 5, 2016).

Pennsylvania's water resources are essential to the commonwealth's health and economic well-being, and they should be given the strongest possible level of protection.
