I wanted to share my support for the Charter Schools. I have been Certified School Nurse for 20+ years and have only worked in Charter Schools. I have a son that attended a charter School K-6 and a son that never went to a charter school, both are successful members of our PA work force! The option to send a student to a charter school is an important choice for parents. The process by which the law is designed needs to remain in the hands of the legislative body who is elected to represent our voices! I am registered voter in PA and I have regularly voted, since I was 18. Below are some key items that I believe could hurt the charter school community:

- The regulations are going around the people and not using the legislative process. They are punitive towards charter schools.
- Redirection Process for Charter Payments - This does not solve the problem and will not change school district behavior. Cost-savings to PDE is microscopic (i.e., the cost-savings is the equivalent of 3 minutes' of expenditures of the annual budget for the PA Dept of Education).
- Application Requirements - Sets a floor but allows school districts to have subjective standards that can be used in an obstructive and punitive fashion towards charters.
