I. CALL OF THE MEETING

A. ACTION ITEMS

1. No. 3362 State Board of Nursing #16A-5143: Licensure by Endorsement and Reactivation

Regulatory Analyst Michelle Elliott, on behalf of Scott Schalles, briefly summarized the regulation, any public input, and noted that the regulation was deemed to be approved by the Standing Committees.

Jacqueline Wolfgang, Senior Regulatory Counsel, Department of State, and Megan Castor, Board Counsel, State Board of Nursing, were present to answer any questions.

2. No. 3397 Pennsylvania Gaming Control Board #125-247: Table Game Equipment; Blackjack; DJ Wild Stud Poker; Interactive Gaming Player Accounts; and Interactive Gaming Progressives
